Springboard's Inclusion Scholarship Terms and Conditions

By submitting an application for a scholarship from Springboard, you agree to the following terms and conditions:

1. Applicant Certifications and Acknowledgments:

You certify that your answers to all questions in your program application and scholarship application (if applicable) are true and complete to the best of your knowledge.

If your scholarship application leads to being awarded a scholarship, you acknowledge that any false or misleading information provided in your application may result in disqualification and revocation of the scholarship.

2. Eligibility:

No purchase or payment is necessary to apply or to be selected as a Springboard scholarship recipient.

In order to be eligible to be awarded any of the Springboard scholarships, you must:

- Apply during the scholarship application period, if applicable;
- Have submitted a complete application to Springboard, met the requirements of your chosen program, and been accepted as a student in the program by Springboard.
 Information regarding admission requirements by course is available on the Springboard website:
- Enroll using our Upfront, Monthly, or Financing payment plans; Deferred Tuition payment plan is not eligible for scholarships at the moment.
- Not be a student who is currently attending or who has signed an enrollment agreement for a Springboard program;

In addition to the requirements above, we have unique requirements for each of Springboard's scholarship offering:

- For the **Women In Tech scholarship**, you must:
 - Identify as a female
 - Be enrolling in our Data, Cyber, Engineering, and Tech Sales courses only
- For the **Diversity-In-Tech scholarship**, you must:
 - Either, identify as one of the following:
 - Black or African American,
 - Hispanic or Latinx,
 - Pacific Islander,
 - Native American and Alaska Native,
 - Middle Eastern,
 - Member of LGBTQ+ community,

- Gender-nonconforming
- o Or, be one of the following:
 - Veteran or member of US military.
 - Person with disabilities
 - Refugee
- For the **Needs-Based scholarship**, you must:
 - Have a household gross income of <=\$30,000, AND
 - Live in the United States or Canada, AND
 - Show proof of income via Paycheck or Tax Return or Unemployment Benefit Claim.

Please note, at Springboard's discretion, alternative documentation may be evaluated for purposes of determining financial need if the applicant does not have access to the standard application documents. In those circumstances, a senior member of our team will review the documentation provided and make a final determination.

3. Scholarship Conditions:

Springboard scholarships provide a specified dollar amount toward the price of tuition for the scholarship recipient(s) to attend one Springboard program. All scholarships are subject to the availability of funds and based on the satisfaction of scholarship conditions. The scholarship awarded may vary at the discretion of the scholarship review committee based upon the number of scholarships awarded and the caliber of applications received.

All scholarship funds will apply to tuition only and will be applied upon enrollment into the course. If your tuition charges exceed the value of the scholarship, you shall remain responsible for payment of the remainder of your tuition obligations. Students will also be responsible for any additional fees associated with their chosen program. Scholarships have no cash value, thus, if you do not complete your program, you will forfeit any funds not applied to your program.

A scholarship may be transferred to another program once the student begins to study in their program. Scholarships may not be applied retroactively. The scholarship may not be applied in conjunction with any other Springboard or Partner scholarship or promotion offering. If a student is a chosen recipient for more than one scholarship, the higher scholarship amount will prevail. There is only one exception to this condition – students can combine either the Women In Tech or Diversity In Tech scholarships with the Needs-Based scholarship, summing to \$1500, if they are eligible for each scholarship individually.

Scholarships apply to the Upfront, Monthly, or Financing payment methods. At the moment, Deferred Tuition applicants are not eligible for a scholarship.

The scholarship may be forfeited if:

- you withdraw or are dismissed from the course;
- you are found to have made any false or misleading statements in connection with your application for the scholarship or the Program;
- you engage in misconduct in violation of Springboard's Code of Conduct or otherwise materially violate applicable policies or any agreement between the student and Springboard.

4. Privacy And Use Of Personal Information:

If you submit an application, we will process your personal data. We need to use your personal data to administer the scholarship program (to assess applicants and to contact you).
